Aloha, Justine. Here's a summary update.

1. FTA HQ requested their contractor to draft a letter to Governor Lingle regarding the need for an SSOA.
  - a. The contractor requested Harry Saporta to review the letter. In turn, Harry requested input from Harvey and Phyllis. Review comments were provided.
  - b. We are waiting to receive a revised draft from the contractor to review.
2. During the December monthly meeting with the HDOT, Harvey mentioned to the HDOT Director that FTA would be sending a letter regarding the SSOA requirement to Governor Lingle. The regulations governing the SSOA were provided to HDOT.
3. I briefed Ed Carranza last month, which basically covered #1 and #1a. Ed advised we take a grass roots approach and not wait for FTA's letter. I told him we would monitor the situation and make a determination when to initiate a letter to the Governor, although our preference is for FTA to make first contact.

I'll be in the office tomorrow until noon so let me know if you need clarification on anything. I'll be off on 12/26 but will return on 12/29. Toru, Simon, and Harvey are on vacation.
