The total cost for both contracts are \$18.2M.

1 DESCRIPTION OF THE CONTRACT/PROJECT

- Kamehameha Station Group Construction (KHSGC"): Contract No. CT-HRT-1600152 Nan Inc.
- West O'ahu Station Group Construction ("WOSGC"): Contract No. CT-HRT-1500503 Nan Inc.

2 REQUEST

CEO/Contracting Officer approval is requested for authority to negotiate a consolidated resolution agreement between Nan, Inc. and the Honolulu Authority for Rapid Transit (HART), with a commercial value between \$16.3M and \$19.5M, pursuant to the terms set forth in the Consolidated Resolution Terms (Exhibit A, attached), in exchange for the full and final resolution of all outstanding issues including; changes, claims, time impacts, and any other issues or requests for compensation as identified in the Consolidated Resolution Terms (Exhibit A, attached), with the exception of station canopy related issues, in process Contract Change Orders, and any future merited changes that may arise prior to Contract Closeout. If approved, this EDD will increase the West O'ahu Stations Group Construction (WOSGC) and Kamehameha Highway Stations Group Construction (KHSGC) combined Contract sums. The benefit to HART to enter into this agreement includes:

- A resolution of the contractor claims and requests for additional compensation contained in Exhibit A, the Consolidated Resolution
 Terms
- Avoidance of future litigation fees, consultant fees, and accumulating interest fees
- Elimination of future claims and project delays due to change order processing
- Mutual cooperation between Nan, Inc. and HART for the remaining construction work and for a more expeditious project closeout
- Mutual agreement on substantial completion dates will support HART's Interim Opening goals

This proposed increase is subject to HART Board approval.

3 BACKGROUND

Executive Summary:

COMMERCIAL RESOLUTION

The current Nan, Inc. WOSGC and KHSGC Proposed Change Order (PCO) logs carry a combined value of \$49,175,860 (WOSGC \$21,061,606; KHSGC \$28,114,254). HART's Change Management documentation, in various stages of the Change Management process, supports a value of \$5,898,115 (WOSGC \$3,656,461; KHSGC \$2,241,654). See Exhibit B, WOSGC Section 1 and KHSGC Section 1, attached.

HART has determined that a consolidated resolution value between \$16.3M and \$19.5M would be fair and reasonable for this resolution agreement. The proposed consolidated resolution shall increase the WOSGC and KHSGC Contract Sums in exchange for the full and final resolution of the aforementioned inclusions.

Proposed Commercial Resolution Background:

(a) Substantiated Compensation:

(1) \$5,898,115 (WOSGC \$3,656,461; KHSGC \$2,241,654) of the proposed Consolidated Resolution value is generated from substantiated changes/claims supported by previous Change Management documentation and Contract requirements.

(b) Exposure Analysis:

(1) Changes/claims exposure:

HART has reviewed the claims and requests for compensation from Nan, Inc, that were originally determined to have no merit, or are new requests where a merit evaluation was pending, in order to establish if HART is subject to exposure related to these changes/claims. The review produced the following findings:

\$10,455,997 (WOSGC \$5,956,241; KHSGC \$4,499,756) of Nan, Inc's request for compensation is determined to have potential exposure to HART.

(2) Litigation/Consultant exposure:

Potential exposure related to attorney fees, expert witness fees, and consultant costs has been estimated to be \$3.2M in the case that a litigated settlement would occur in 12 months. The objective is to pay a portion of the exposure value, in a settlement environment, in order to avoid a larger cost if resolution were sought through litigation. The range proposed to be included in the consolidated resolution value is between \$0M and \$3.2M. See Exhibit B – Consolidated Resolution Summary, attached.

(3) Maximum Exposure:

HART's maximum exposure could be in excess of \$55M including interest, litigation, and consultant exposure. See Exhibit B-Consolidated Resolution Summary, page 5, Exposure Considerations - attached.

(4) Realistic Exposure:

A more realistic exposure could be between \$18.8M and \$22M. This is supported by the HART exposure analysis and the HART Risk Management System's register as of August, 2019. It is approximately 35% of HART's total maximum exposure. See Exhibit B - Consolidated Resolution Summary, page 5, Exposure Considerations – attached.

Commercial Consolidated Resolution Conclusion:

 Based on the substantiated changes/claims and the potential exposure, described herein, a consolidated resolution value between \$16.3M and \$19.5M in exchange for the resolution of all contractor change requests and claims (with the exception of station canopy related claims, and Contract Change Orders in process), the avoidance of litigation/consultant costs, and an agreement on substantial completion dates supportive of HART's Interim Opening, would be a reasonable outcome of the negotiations. Acknowledging that it is subject to HART Board approval, HART seeks authority to reach a mutual agreement on the proposed Consolidated Resolution Terms for both the WOSGC and KHSGC contracts.

Request Approval for Consolidated Resolution Agreement

Contract No. CT-HRT-1500503 **West Oahu Stations Group Construction Contract** and

Contract No. CT-HRT-1600152 **Kamehameha Highway Station Group Contract**

Purpose

- These change orders request the approval for a Consolidated Resolution to resolve listed outstanding claims, requests for changes, impacts and issues, and extend the substantial completion dates.
- The total cost for both contracts is \$18.2M.
 - WOSG: The cost is \$11,329,993
 The contract will increase from \$75,814,449 to \$87,144,442
 - KHSG: The cost is \$6,870,007

The contract will increase from \$124,284,262.86 to \$131,154,269.86

■ These additional funds will come out of budgeted allocated contingency for the west-side, and the total cost of the Project without finance costs remains at \$8.165 billion.

West O'ahu Station Group Construction Background

- Nan, Inc. was awarded the WOSGC contract on July 20, 2015, for \$56,088,470.
- The contract was originally for 29 months, and work is currently expected to run through January 31, 2020.
- Thirty-two change orders have been issued to date for a total cost of \$19,725,979.
- Most of the increased costs were due to design and interface changes and time delay.
- The current value of the contract is \$75,814,449.



Kamehameha Highway Station Group Construction Background

- Nan, Inc. was awarded the KHSG contract on December 22, 2015, for \$115,805,845.
- The contract was originally for 32 months, and work is currently expected to run through April 30, 2020.
- Forty-three change orders have been issued to date for a total cost of \$8,478,417.86.
- Most of the increased costs were due to design and interface changes.
- The current value of the contract is \$124,284,262.86.



Change Order Considerations

- Proposed WOSGC Contract Change Order (CCO) No. 00033 and KHSGC Contract Change Order (CCO) No. 00044 are based on the outcome of negotiations with Nan, Inc. to resolve listed outstanding change orders, requests for changes, claims, and issues.
- Negotiated amount is based on both substantiated changes, claims, and potential HART exposure to changes and claims.

Benefits to HART

- Elimination of future claims and project delays.
- Avoidance of future litigation fees, consultant fees, and interest accumulation.
- Cooperation between Nan, Inc., and HART for the remaining construction work and for expeditious project closeout.
- Mutual agreement on substantial completion dates will support HART's Interim Opening goals.

Requested Action

- Approve WOSGC and KHSGC Contract Change Orders in the combined amount of \$18.2M in exchange for the full and final resolution of all outstanding or potential Nan, Inc. claims, requests for additional compensation, and items that are not included in this agreement (canopies and works associated; other changes that are yet to be fully defined; and changes in process that are time-sensitive.)
- HART previously forecasted for these Change Orders within the budget line item, and sufficient funding is available in the Project budget. Unallocated contingency is not required to be used for this change.
- There is no change in the Project Budget of \$8.165 billion.
