What about this change: “your proposal to modify a small section of the Honolulu rail project's ~~preferred~~ alignment.” I hesitate to use the word “preferred” because it makes me think of “locally preferred alternative,” which opens up another whole train of thought about needing MPO action to redefine the preferred alternative. Sort of like Chris’ hesitancy to use “alternative alignment” because of the 4(f) terminology. But I don’t feel strongly about this.
