**RE:** Meeting with Honolulu Mayor Mufi Hannemann

### MEETING OVERVIEW

You will be meeting with Mayor Hannemann who will be inquiring on progress towards completion of the Final Environmental Impact Statement (FEIS) for the Honolulu rail project. With the mayor will be Todd Apo, current chair of the City Council and a rail supporter; Toru Hamayasu, Chief of the City's Rapid Transit Division; and perhaps another councilmember still to be determined.

### TOPIC OF MEETING & TALKING POINTS

The mayor is likely to ask about a variety of topics related to near-term closure on the Final Environmental Impact Statement (FEIS) and the position of Hawaii Governor Linda Lingle on the project. Likely FEIS topics are the Programmatic Agreement (PA) for Section 106 historic resources and impacts on operations at Honolulu International Airport.

**PA:** FTA has completed its review of the draft PA and has forwarded the document to the Hawaii State Historic Preservation Office (SHPO) for its concurrence. FTA staff will meet with SHPO staff in Washington on March 1. FTA anticipates no major changes to the PA and expects the availability of a final PA document for signature within the next several weeks.

**Airport:** FTA awaits the findings of the Federal Aviation Administration regarding the impacts, required mitigations, and costs consequent to the City's preferred alignment through the airport. Preliminary indications are that the impacts and mitigations are substantial. At this point, it may be prudent for the City to develop all information necessary to document in the FEIS one or more alternative airport alignments that would avoid these impacts. (City staff have voiced hope that FTA will "push back" against this outcome; the mayor may also.)

Regarding the governor's position, the mayor may ask about her recent meeting with Secretary La Hood and you and offer various counter-arguments to her public statements on the cost of the project, the financial plan, and her plans for a detailed review of the FEIS and the financial plan. You have indicated that in the recent meeting, Governor Lingle stated that she will conduct an independent review of the project's financial plan. She has asked for access to the same financial data that FTA will be using in its Financial Capacity Assessment. These data are public information upon the City's submitting them to FTA.

The mayor may also ask for expedited closure of issues related to the initial design-build contract that the City has executed with a contractor team led by Kiewit Pacific. FTA staff have been working with the City to ensure that the contract work undertaken in advance of an environmental Record of Decision for the project complies with applicable FTA guidance. FTA staff expects closure on this issue by the next project-oversight meeting in Honolulu, scheduled for the first week in March.

### NOTABLE BACKGROUND

The entire Hawaii Congressional delegation has been supportive of this project, particularly Senator Inouye.
