Hi Pua –

The draft Stipulation III that was sent last night responds to the comments that were received at yesterday's meeting. The only other item that the archaeological task force asked for was a WHEREAS clause that acknowledges that the City is cognizant of the burial issue on the Halekauwila Alignment and that the OIBC may be put in the position of having to make the decision that iwi will need to remain in place. We have asked FTA to look at proposed language, before we send this out for wider review and comment. It is our thought that the work of the task force will be complete upon receipt of whatever comments are received today.

We want to send out the latest PA at the end of the day today, sans the above described WHEREAS clause. The decision then would be whether another meeting of the consulting parties will be necessary. I don't know if Susan mentioned to you, but Blythe (ACHP) will be out of the office from next Thursday until 10/16 and so if we need to consider her schedule, it may be difficult.
