I talked with Joe Ossi about the cover page and the rest of the process.

Cover page: Remove RE-ISSUE OF ADMIN REVIEW DRAFT.

Next page: In the legal citations, all the upper case letters should be lower case, for example 5301(E) should be 5301(e) and 4(F) should be 4(f) along with the others. Also for the Historic Preservation Act citation, there should be no parenthesis, it should be 470f.

Remove the line at the bottom and all page numbers - in other words in this part no footers on any of the pages.

Since we are unsure of the timing, we suggest Cheryl sign two signature pages, one for the Regional Admin to sign and the other will say Acting Regional Administrator (unless we know we will miss this week).

Also, Joe Ossi says that after you have the signed page back and it goes to the printer, the distribution to all agencies must be made. You should then call or e-mail him to notify him that the distribution has been made and that you are express mailing to him 10 copies of the document. Joe will go to the EPA and deliver the copies. If he receives the 10 copies by this Friday, August 11th, then it will be published the next Friday, August 18th. You will calculate the 45 day comment period from the date that the EPA publishes it in the register. If you miss this Friday, then it will be the next Friday to get to Joe (Aug 18th) and it will be published August 25th.

You will also mail 10 copies to the Department of the Interior. I'll have that address tomorrow.

Please call Joe by Thursday if you know the documents will arrive in Washington, DC this Friday at 202 366-1613. Joe will be out Friday, and will need to make arrangements to have someone else take the documents to the EPA.

I have finished my review of the current comments and you have them all. Joe also concurred that Jim Kenna can sign as Acting Regional Administration this week, if

needed.

This should help with your time frame computation. I'll be in Tuesday by noon. I will be on vacation from Thursday noon until Monday, August 21st. I will brief Hymie Luden on the status of your project, so he can see it through, if you don't make it this week.
