We have had several discussions with the FTA this week and last, regarding FTA's approval for the project to enter into PE. One of the issues still outstanding is the approval of the FTA deliverables. FTA has requested that a copy of each of deliverables being submitted for our review also be transmitted for FTA review.

Because there are still sections within the PMP that need to be revised I do not advise sending a copy of it to FTA for review.
