Faith and Toru,

FTA's call today with the FAA and HDOT raised serious issues for the release of the FEIS. FAA approval, including a NEPA finding, is required for any use of airport property and it appears that FAA will need to become a cooperating agency. HDOT staff continue to raise questions as to why the airport would give up eligible uses for runways 22R and 22L and thus restrict future options as they did in my October 19 meeting at the airport. FAA indicated that HDOT does not have sole authority to make changes in the use of runways and FAA approval is required. FAA must approve the location of any station or alignment on airport property. FTA will continue to coordinate with FAA to determine a path forward.

Faith, we have at least 5 major issues, 1) PA, 2) Airport RPZs, 3) 4(f), 4) signature authority and 5) response to comments. Your avoidance option for the park in figure 5-5 is a logical approach for 2 reasons. It avoids the RPZ at the airport and avoids the 4f resource. Further delay in resolving this airport issue just delays FTA's final review of the document. Ray
