Donna:

There are some things that were not discussed, but should be understood. DTS is doing what we call "Option 1" project development. This is systems planning and alternatives analysis which is concluded with an AA Final Report followed by project entry into PE. FTA reviews and approves documentation along the way to PE. Then NEPA public scoping and NOI occur followed by a DEIS, public hearing and FEIS and ROD. Finally, FTA makes a decision on project entry into final design. They are not currently in the NEPA process. They are doing a stand-alone AA.

As for our discussion, the size of minority populations are of less concern than the potential environmental effects on them. It's important to point out benefits to these sub-populations. Research may indicate that there are other groupings of sub-pops. including children, the elderly or the handicapped. They should develop a "Community Profile" after their initial data gathering that will inform their outreach and public involvement. They should then develop a "Public Involvement Plan" that will determine strategies for public involvement and community input. Also, they can use travel demand modeling to locate transit dependant populations.
