I have asked for permitting information and all they sent us was information from the company's website.

I am not counting on them to give us more information.

So through a quick Google search I found that the Hawaii State Department of Health is responsible for all Air Quality and NPDES permitting. In 2008, the GPRM Prestress LLC applied for an air quality permit. Unfortunately, it does not appear that they provide the permits online. However, we can call the State at 808-586-4200.
