Comments on the FEIS for Honolulu Rail Project are as follows:

1. Thank you for clarifying that the alignment modification at the airport remains the same as presented to FHWA in an earlier meeting. As the project proceeds through the development process, we request continuing coordination with the Rail Project group to ensure the transit infrastructure within the Interstate ROW, at the airport and other locations, does not impair the highway operation or jeopardize the safe flow of traffic during construction, operation and maintenance of the transit facility.
2. Table 4-40 cites a project nexus with Interstate H201. Our files indicate the western limits of Interstate H201 is H-1. We suggest that the limits of Interstate H201 be verified with the HDOT. HDOT keeps the official designations of all routes.
3. Also, Page 3-54 and Table 4-40 overlook the role of HDOT in the areas of airspace approvals and access modification. In both of these approvals, the request and information is sent to the DOT for analysis first. Recommendations made by the DOT are then sent to the FHWA for concurrence and approval. The addition of text discussing HDOT's role will more accurately reflect the approval process that must be followed.

Thank you for extending me the courtesy of the additional days of review time.

The eastern portion of the airport alignment is where a refinement has been made to go from Aolele Street to Ualena Street in the vicinity of extension of Ohohia Street. This was to keep outside of the runway protection zone.
