Hi Joe,

Leslie was not involved in the Governor's call. I believe it was only Jenna Dorn and Mary Peters. Subsequently, last Tuesday, Ron Fisher, Leslie and I were involved in a call with the Administrator. She talked a Governor's task force to improve island transportation. She talked about her desire to provide technical assistance to Hawaii and we discussed various approaches. She also asked that I develop a list of talking points for her to use that would develop the points raised in the discussion. Below, I have attached a draft copy of the talking points which I sent last Thursday. At this point, I do not see any direct impact or decision on the first phase or IOS of the BRT.

On the BRT NEPA work it seems that there is little progress. We sent interim comments awhile ago, have not seen an outline of the new document and they still seem to be quibbling over signing an MOA with SHPO. Considering the timelines, I would have expected that the new FEIS with an IOS would have been on the "street" by now.
