

## **Appendix B Land Commission Awards in the Vicinity of Airport Section 3 Project Area**

---

This appendix presents transcriptions and/or photocopies of original award information for seven Land Claim Awards identified in the immediately vicinity of the Airport Section 3 corridor. These transcriptions (largely drawn from the Waihona 'Āina website) contain information obtained from the following sources: Land Commission Awards (LCAs), Foreign Testimony, Native Testimony, and a review of historical documents and maps. This information appeared earlier in Appendix A of the Archaeological Inventory Survey Plan prepared for this project (Hammatt and Shideler 2011).

## **LCA No. 818 to G. Beckley (Kalihi)**

### **LCA No. 817 to 821 to G. Beckley, Transcription**

**No. 818, [G. Beckley], A. H. Fayerweather /or Heirs of George Beckley, Honolulu, Oahu, Hawaiian Islands, October 22, 1847, Claims 817 to 821

To Honorable William Lee & others, &c, &c, &c.

Gentlemen: In pursuance of the public notice, I, as attorney for the heirs of the late George Beckley, beg leave to present the following claims of the said heirs.

[817] Cl. 1. To one farm with the fishing grounds attached called Kealahewa, situated in the district of Kohala, Island of Hawaii, given to said George Beckley by King Kamehameha I about or in the year 1811, subject to the division made, or to be made, of such lands as are held under like circumstances.

818 - Cl. 2. Also to one farm with the fishing grounds attached called Kaliheawa, situated in Kalihi, Island of Oahu, given to the said George Beckley by Keopuolani about or in the year 1815, subject to the division made or to be made of such lands as are held under like circumstances.

Both of the above named farms with fishing grounds attached have been in the uninterrupted possession of the said George Beckley and his heirs from the time they were given; the said George Beckley to the present time.

819 - Cl. 3. Also to one farm called Kawailole, situated at the mouth of the valley of Manoa, Island of Oahu, sold to the said George Beckley by Kalaimoku (then Governor of Oahu) about or in the year 1815 and was in the uninterrupted possession of the said George Beckley and his heirs until 1827, when on 7th day of March 1827, said farm was left to Richard Charlton by Poki, Governor of Oahu, for the term of 28 years, to be returned to the heirs of the said George Beckley at the expiration of said term.

820 - Cl. 4. Also to one premises situated in Honolulu, Island of Oahu, given to the said George Beckley by the King Kamehameha I about or in the year 1819, which premises have been enclosed, built upon and occupied by the said George Beckley and his heirs ever since that time. Said premises are bounded:

On the northwest side by the public street

On southwest and southeast by premises of natives and a lot of ground at present occupied by John Voss.

821 - Cl. 5. Also to one premises situated in Honolulu, Island of Oahu, given to the heirs of said George Beckley by the authority of Honolulu, in place of a piece of ground cut off from the premises (received of King Kamehameha I in 1819) as above named, at the time said authorities altered and improved the streets of Honolulu; now in the undisputed possession of the said heirs and under them, in occupation of John Sweetman. Said premises are bounded:

On southeast side by the public street

On southwest by premises owned by Samuel Thompson  
and northwest and northeast by premises of natives.

No. 817, 818, 819. The Heirs of George Beckley, viz[?] Ahia (Widow of Beckley) William Beckley, Maria Beckley (wife of Kamakahonu), Abram (infant child of Nancy Beckley), Mary Beckley (wife of A.H. Fayerweather, George Frederick Beckley (absent from the Islands since 1834 and last heard from in 1841 at Valparaiso), Marie Beckley (wife of George W. PUNCHARD).

A.H. Fayerweather, as attorney for the heirs, stated that the land comprised in these three claims were given by the King (at the late division of lands) to the heirs of Beckley without any division, and that he had presented a certificate to this effect to the President of the Board which could not be found: case postponed until another can be obtained). He further stated that in the late division, the King left these lands untouched, and took three other lands on Hawaii called "Muliwai" in "Waipio." "Waalooa," or Kihapai and Pualoalo in Kohala (See William Beckley's claim No. 976).

Received of Mr. Richard Charlton the sum of five hundred dollars (\$500) for which he is to have the full and entire use of the Estate known by the name of Wyderry free of all taxes, charges or quit rent or labor demanded of the men on said estate for the term of twenty-eight years from the date hereof.

In the name of God Amen.

I, George T. Beckley, being of weak body but of sound mind and memory, do hereby make and declare my last will and testament. First, I bequeath unto my children and to the mother of my children all my personal property and all the lands I now hold under the Government of these islands, to be equally divided among them, and it is my wish that the mother of my children may have the management of the same until my eldest son is of age and then it is my wish and will that my eldest son, William, may have the management direction of the same. Second, I wish that my son, William may be under the direction of the young King, and in case he, my son William, may wish to go to the Spanish main, it is my desire that he may go and return again to these islands.

Third. I wish My daughters to be under the direction and guardianship of Captain Alexander Adams, to do and advise (for them as he may think fit & proper) and I request my executor to have my body decently interred in the house I have commenced building as he may think most advisable.

And I hereby appoint Captain Alexander Adams to be my executor of this my last will and testament. (original without staps [stamps?]) (JHL)

There is one fishpond and a kula, at another place, but together in the same `ili.

Keawe, sworn, I know this land. It is in the ili of Kauana, Hālawā, Ewa, Oahu. It consists of kula ground and four lois in one piece, and one fish pond in another place.

The claimant received these lands from Kamalanai in the time of Kamehameha II, and his title is without dispute. Governor Kekuanaoa is the Lord of this land.

The land consists of two distinct pieces. First A loi kalo & kula adjoining in the ili of Kamau, Hālawa, Ewa, Oahu. 2d, A fish pond on the sea shore which is a lihi aina of the said ili aina Kamau.

It is bounded, i.e. no. 1:

Mauka by a loko kalo named Kuheleloa

Honolulu by a loi called Waiamahiwi

Makai by the lois Peahinaia & Kumukui

Waianae by the koele called Pohakea.

No. 2, the ~~bounded~~ fish pond is bounded:

Mauka by the kula of Hālawa

Honolulu by a loko called Waialua

Makai by a fish pond called Lokoloa

Waianae by a fish pond called Lokoloa.

Claimant received the land from Pawela in the time of Liholiho & has held quiet possession ever since.

Keawe, sworn says, I know the land of claimant and the testimony of Kaupali is correct.
